# **POSITION PURPOSE AND OBJECTIVES:**

The Senior Policy Analyst handles an array of program and policy responsibilities for the Institute as to carry out this goal as listed below.

The ideal candidate is a person who is passionate about the role public policy should play in helping families reach financial well-being and is a highly motivated team player.

### **CORE RESPONSIBILITIES:**

The core responsibilities of this role will be managing a portfolio of policy issues as they relate to working families. This includes, but is not limited to:

- Developing/retaining subject matter expertise on the issues in the portfolio;
- Making the best use of individual strengths and the strengths and resources of IIWF to advance policies in the portfolio that help Hoosiers earning low incomes to reach financial well-being and realize their full potential within our communities.

#### **SPECIFIC RESPONSIBILITIES:**

To meet the core responsibilities, the Senior Policy Analyst will efficiently and effectively:

- Research and data analysis related to issue portfolio. Including analysis of existing and emerging program and policy areas on the federal, state, and local levels.
- Monitor and analyze implementation of state and federal laws and legislation as related to low-income working families and prepare reports that convey to the public the impact both positive and negative of policy and legislative proposals, especially as they relate to the economy and state fiscal policy.
- Participate in research projects on which you are lead or supporting role to produce policy briefs, memos, and full-length reports as required by grants/funders.
- Develop policy recommendations (in consultation with Director and team) for reports and Institute's public policy agenda based on national best practices and models. This may include drafting legislation or rule change language.
- Ensure timelines for grants and work projects are met.
- Provide editorial and content feedback on Institute's written pieces.

- Create and maintain strong media relationships including formulating a media strategy, authoring press releases, and following up with specific reporters to publicize Institute's research and public policy agenda/recommendations.
- Present on Institute research and agenda to funders, lawmakers, policymakers, and service providers.
- Maintain relationships and attend relevant conferences and meetings to maintain relationships with national and state partners, government officials, and funders.
- Support the Director in helping to apply for private foundation grants, including the creation of proposals, cover letters and supporting documentation.
