¹This reflects the population for whom poverty status is determined, which excludes individuals living in institutional group quarters (such as prisons or nursing homes), college dormitories, military barracks, living situations without conventional housing (and who are not in shelters), and unrelated individuals under age 15 (such as foster children).



The Causes and Conditions of Poverty

To understand the important work that Indiana's Community Action Agencies do, it is first important to understand the mission they serve: addressing the causes and conditions of poverty. When President Lyndon B. Johnson declared war on poverty in 1964, he launched a movement that resulted in the development of Community Action Agencies. "Our aim is not only to relieve the symptom of poverty, but to cure it and, above all, to prevent it," said President Johnson in his State of the Union address. Community Action Agencies, born out of this aim, fight poverty by providing direct services to meet basic needs, offering education, boosting employment, and providing family-centered support to those who struggle across the lifespan.

Poverty has been defined and measured in several ways, as explored below, with each definition offering insight into the realities of individuals who struggle and the ways in which Community Action Agencies can support the well-being of our fellow community members.

Defining and Measuring Poverty

There is no universally agreed-upon definition of poverty. When most people think of poverty, they think of economic poverty, such as:

- not having enough money to pay the bills or buy food for dinner;
- when a bank account hits zero and high-cost debt is incurred; or
- when a salary does not fall above a designated threshold, such as a poverty level.

These are common ways of describing and measuring poverty.ⁱ However, poverty can't be easily captured by a set of static numbers. Poverty can be defined as the absence of necessities:

- consistent caloric or nutritional deficiency resulting in stunted growth;
- an apartment without heat in the winter;
- a prescription that is not filled because of high cost; or
- a pair of shoes that does not fit anymore.ⁱⁱ

A third conception of poverty could develop this list further, including deprivation not just of basic survival necessities, but also social survival necessities that depend on the context in which people live.ⁱⁱⁱ In Indiana, this might include:

- the absence of internet at home;
- a lack of transportation contributing to social isolation; or
- an inability to access books or school supplies that are critical to learning.^{iv}

As these examples illustrate, there is no clear-cut way to determine poverty: this concept lies at the intersection of other complex issues. In the United States, poverty was first measured using a threshold of three times the cost of a minimum food diet in 1963, and in the following years has been adjusted for inflation and in accordance with family size. In 2025, the Federal Poverty Level was \$15,650 for a single individual, and at higher thresholds for households of larger sizes. While measuring household income against these thresholds captures severe instances of poverty, it also results in undercounting and understating the number of individuals and households experiencing hardship for a variety of reasons.

Defining poverty in this monetary way, as we do in the United States, means that people will be counted as not being in poverty as long as they are above an income threshold, even if that income threshold doesn't account for a specific cost of living - such as an expensive medication - that might mean the monthly budget needed for one person is higher than another.^v This definition of poverty also privileges participation in the economy, while a definition of poverty that focuses on experiences (experiencing hunger, experiencing cold in winter months, etc.) would measure and prioritize changes in these experiences.^{vi} To the extent possible, Community Action Agencies can and should explore metrics beyond the boundaries of poverty statistics, focusing also on the experiences and hardships that prevent individuals from living a dignified life, performing their best, and contributing back to the community and the world.

The Causes of Poverty

Just as there is difficulty agreeing on one specific measurement as the superior choice for documenting poverty, there is also disagreement on the origins of poverty, as well as the nature of poverty as a societal issue. Four different strands of scholarly debate - individual, situational, structural, and political - speak to the oft-asked question: "Why is there poverty?" Understanding these strands and why one might be more relevant than another is critical to furthering understanding of the values underpinning choices made to address poverty.

The “individual” strand presents the idea that personal decisions are the reason that poverty exists. People experiencing poverty, this strand argues, experience it because of the choices they made.^{vi} This strand links closely with the second theory of poverty - that situations are a root cause of poverty. Though similar to the individual strand, the situational explanation of poverty suggests that conditions, such as a natural disaster or the bad luck of having an expensive medical condition, are the core causes of poverty. Unlike centering on the individual as the root cause of poverty, recognizing how different situations can cause poverty suggests that poverty is a natural state and one that many people cycle into and out of during their lifetimes.

Other theories of poverty focus on wide-scale systems and how those interact with individuals to create hardship. This can include community-wide phenomena and the decisions made by policymakers, particularly those made around social safety net planning and market regulation.^{vii} Structural and political theories also account for historical patterns that have contributed to a greater likelihood of experiencing poverty among groups of people.

Community Action Agencies can and do work across levels - from shaping individual behaviors to influencing federal and state policies - to prevent and address poverty.

Conditions of Poverty in Indiana

Even with COVID-19 in the rearview mirror, this event has continued to shape experiences and dynamics of poverty nationwide.^{viii} Indiana has been hit especially hard by the cost-of-living crisis in the post-pandemic era, the housing crisis, and the expiration of COVID-era supports.^{ix} Harms from rising costs affect not only unemployed individuals but also many working Hoosiers, increasing the struggle to afford daily necessities.^x

Increased financial hardship on vulnerable families has the potential to turn into cycles of poverty and generational harm.^{xi} When Hoosiers cannot invest in themselves or their loved ones at a level that is needed for thriving, this can lead to declines in health, harm to educational outcomes, and worsening future prospects. Addressing the conditions of poverty is part of the work of Community Action Agencies, and examples of conditions of poverty in Indiana can be found below.

Conditions of poverty extend beyond access to daily necessities and future opportunities to encompass mental and physical health - with life-and-death implications. Medical debt, environmental pollutants, and unsafe housing conditions combine with inaccessible medical facilities of varying quality and lack of fresh, nutritious food to create higher mortality rates for individuals in low-income communities.^{xii} This comes on top of research that documents the mental health impact that poverty can have on the well-being of both adults and children alike, with elevated stress levels and increased rates of depression further feeding into physical health harms.^{xiii}

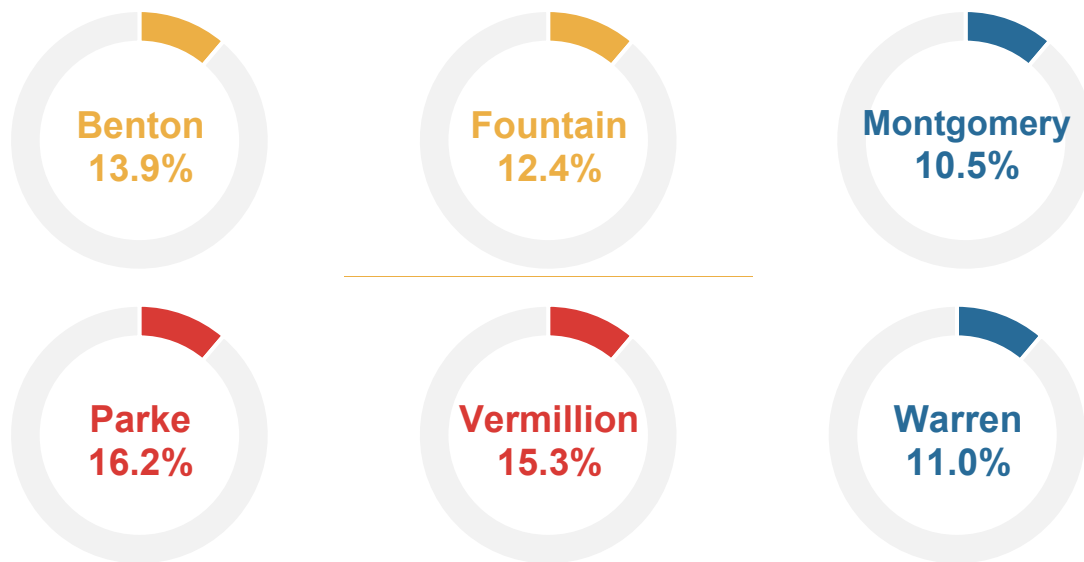
Poverty and its associated harms are not equally distributed across demographic groups. Rather, because of historic and modern social conditions and policy choices, poverty disproportionately affects women, young children, people of color, non-citizens, single parents, individuals with disabilities, and others with these intersecting identities.^{xiv} While this does not mean there is no poverty among individuals without these identities, it draws attention to the ways in which past conditions and ongoing patterns shape present situations and opportunities.

² The definition of homelessness by the United States Department of Housing and Urban Development (HUD) is more restrictive than most definitions of homelessness, and excludes individuals who are couch surfing, staying with friends/family, or otherwise able to stay off the streets, even if they lack a shelter of their own.

These are patterns and harms that Community Action Agencies must be aware of to fully address. A more complete understanding of the forces shaping experiences of poverty and the associated conditions will support the development of better solutions, creating a state in which everyone is able to thrive and reach their fullest potential.

Community Action Agencies can:

- Engage staff in reflection on assumptions about the causes and conditions of poverty
- Ensure that all individuals receive fair and equitable treatment through ongoing internal and external evaluation
- Be responsive to disparities in poverty through programming selection
- Collect data on the causes and conditions of poverty in their service area



Methodology

This needs assessment presents the top needs as selected by low-income residents in CAPWI's service area. It also includes feedback and perspectives from community residents and partners, as well as secondary data from publicly available sources that shed light on the causes and conditions of poverty in the area.

Survey of Low-Income Residents

In January and February of 2026, the Indiana Community Action Poverty Institute and CAPWI invited clients and other community members to complete the surveys in Appendix 1. Invitations and reminders were sent to client email lists, posted on social media, and shared through posters in the community. The survey consisted of multiple-choice and open-ended questions.

During the data analysis process, the research team removed repeat responses and retained incomplete surveys to honor the time spent by all participants in their attempt to complete the survey. Key questions, such as screening for county of residence and income as well as identifying top needs, were placed first in the survey. Responses to the low-income resident survey were filtered to ensure that only residents from the counties that the agency serves who are low-income (below 200% of the federal poverty level) or who recently experienced financial hardship were included.

Survey of Community Partners

Secondary Data

While a primary focus of the community needs assessment is elevating the voices and expressed needs of low-income Hoosiers, secondary data drawn from the U.S. Census Bureau's American Community Survey and other sources provide valuable supplemental information about the service area throughout the report.

The American Community Survey is conducted yearly and sent to a sample of approximately 3.5 million addresses in the 50 states, District of Columbia, and Puerto Rico. It asks about a range of topics, including education, employment, internet access, and transportation and typically achieves a high response rate (82.9% in 2024). Local, state, and national leaders depend on the American Community Survey to understand local issues, develop programs, and distribute funding.

The Department of Housing and Urban Development (HUD) produces annual Fair Market Rent (FMR) calculations by county and metropolitan area. The FMR is the 40th percentile of gross rents for typical, non-substandard rental units occupied by recent movers in a local housing market.

The Bureau of Labor Statistics' Occupational Employment and Wage Statistics (OEWS) program produces annual employment and wage estimates for over 800 occupations. Estimates are broken into metropolitan and nonmetropolitan areas. Data is obtained by surveying private sector and governmental establishments, with over a million establishments collected over a three-year period. These and other secondary data sources are used in the report to speak to the scope and nature of needs facing local communities and thereby assist in strategic planning.

³ Respondents could choose more than one organization type, so numbers may total up to a greater sum than the total respondents.

Community Needs

Understanding what holds residents back from achieving and maintaining financial well-being can ensure that community members are better able to live healthy and productive lives. The primary method of establishing needs was through direct consultation with low-income Hoosiers in the service area. This process used a client survey to identify the top five needs in their community using a pre-established list of 19 common needs that were randomized for each respondent. Respondents were then asked to identify and explain their top choice. These open-ended responses enable this survey to represent Hoosiers' needs in their own words. For each identified need, a selection of the respondents' own words is used to explain the perceived need, while research studies and secondary data provide additional perspective on the relationship between the need and experiences of poverty.

Top Community Needs

The following top five needs were identified based on low-income Hoosiers' responses and are compared to the needs identified in CAPWI's 2024 needs assessment. They are listed in order from most frequently selected to least. The clients' top five identified needs are discussed in depth below.

Community partners identified (1) quality and affordable housing' (2) affordable and accessible childcare; (3) transportation support; (4) food assistance; and (5) utility affordability and assistance as the top needs.

⁴ This is the first year that utilities have been included as a separate section in the community needs assessments, added due to community input. Previously, utilities and struggles with utilities were captured under the "Housing" section, but affordable utilities have become an increasingly distinct need for households.

Quality and Affordable Housing

Indiana is currently facing a housing affordability crisis, with only 34 accessible and affordable homes for every 100 extremely low-income Hoosier households.^{xv} Once a home is obtained, lower-income households are more likely to be exposed to poor housing conditions, such as lack of proper insulation (leading to higher utility costs), lead paint, pest infestation, poor ventilation, and water leaks.^{xvi} These conditions impact residents' daily lives, causing negative mental and physical health outcomes.^{xvii} Poor housing conditions can also have long-term impacts. For example, childhood exposure to lead paint through ingestion (eating paint chips, dust from crawling on the floor) can cause behavioral health problems and learning disabilities in children.^{xviii}

“We need more income-based apartments. My daughters have decent jobs and still struggle to pay their rent, after paying the bills, food cost, and personal products.”

For those who can obtain housing (even with poor conditions) in the U.S., millions yearly are at risk of experiencing housing instability, and one in six children experiences unstable housing.^{xix} With housing being a core basic need, rent or mortgage payments often become the first item paid when money comes in: “the rent eats first,” before other needs are met.^{xx} Low-income Hoosiers disproportionately experience cost increases due to their fixed and/or limited budgets and risk falling behind and experiencing eviction or foreclosure. Lacking stable housing has a significant negative health impact; for instance, the stress related to evictions and the loss of housing for children has been found to contribute to increased negative mental health outcomes such as depression and anxiety, which are more severe in younger children.^{xxi}

“Rent is exponentially higher than it was just two years ago. People can’t afford to repair their houses to make them safe again.”

IN HOOSIERS’ OWN WORDS

“There are hardly any places available and that people can afford these days.”

“We are living with black mold and in a 1-bedroom house with 4 people.”

“We need more resources to help with fixing expense broken things in our home.”

“Many live paycheck to paycheck and do not have the extra money to make repairs to their homes. Many go to laundromats, have leaking roofs, need steps or ramps installed, need plumbing repaired, have water damage from leaking roofs, etc.”

When looking at cost-burdened households (spending more than 30% of their income on housing), it is estimated that one out of three households with children are cost-burdened.^{xxii} Children are at greater risk of experiencing evictions compared to other age groups, and those who have children in turn have higher risks of experiencing housing instability.^{xxiii} Children who experience evictions have an increased risk of numerous challenges, including experiencing food insecurity, being exposed to environmental hazards and facing long-term negative physical and mental health outcomes.^{xxiv} Evictions are also one of the primary causes of homelessness, which has both long-term negative impacts on the financial well-being and health of Hoosiers who experience homelessness.^{xxv}

Homeownership barriers also stem from unequal access to and distribution of fair credit, especially by socioeconomic status.^{xxvi} Hoosiers across the state are experiencing struggles with housing, and the dream of owning a home or simply having a place to call home has become difficult for many to obtain as the housing crisis continues.

CAPWI's Current Strategies:

- Connect Hoosiers in need with Housing Choice Vouchers
- Connect individuals with Individual Development Accounts so they can save to purchase a home
- Provide safe and decent housing in the area
- Connect families with emergency housing help and local resources
- Work with local landlords to help families keep their housing
- Offer budgeting and money management help
- Provide referrals for home repairs and housing programs

Possible Future Strategies:

- Provide weatherization and other housing quality improvement services
- Offer eviction diversion support
- Participate in the Continuum of Care to address homelessness
- Continue to invest in or collaborate to create affordable housing options
- Build more partnerships to create affordable housing
- Expand weatherization and energy-saving programs
- Work with landlords to increase affordable rental units
- Partner with ongoing services for homelessness and transitional services

Good Jobs with Adequate Wages, Benefits, and Opportunities

Poverty affects the types of jobs people take, as those who are lower income and without the means to weather a longer spell of unemployment are more often forced to take *any* job to meet their financial needs, regardless of wages or other preferences.^{xxvii} What counts as a “good job” can be difficult to define, but factors that promote a worker’s job satisfaction and well-being can be considered indicators of job quality.^{xxviii} Short-term jobs, those that vary in terms of scheduling, and those that have high physical intensity can place an individual at risk of experiencing poverty while working.^{xxix} Workers with less formal education and those who have recently experienced unemployment may experience higher likelihood of unstable or low-wage employment. In comparison, a good job includes being able to work independently, providing a secure and high-income position, being seen as useful and helpful by the employee, and applying the skills of the worker. These aspects of a good job are connected to the well-being of workers, who in turn show a greater investment in their job security, flexibility, and financial stability.^{xxx}

Lack of good jobs that provide financial stability impacts the whole household, including children, due to reduced income, which can have negative impacts on their cognitive, physical, and social behavioral health.^{xxxi} Parents who are experiencing economic distress can also become more frustrated and have difficulty responding to their children appropriately due to external financial pressures. This reinforces the importance of financial stability, especially when considering the impacts on future generations.^{xxxii} Upskilling is one approach to moving those in bad jobs to good jobs, with training focused on equipping people to become skilled workers in jobs that are not easily automated.^{xxxiii} With the continued increase in automation and technological advancements, there will be a continued decline in good jobs that provide a livable wage for those whose educational attainment stopped at a high school degree or less.^{xxxiv} Therefore, providing pathways to support upskilling during this key technological transition will help ensure individuals’ ability to retain financial stability.^{xxxv}

IN HOOSIERS’ OWN WORDS

“Good job with higher wages so I can actually afford groceries, gas, finding work and daycare/babysitter for my kids.”

“We just can’t seem to make enough to get ahead.”

“Good jobs with higher wages because nothing is affordable anymore and we are all struggling to afford everyday items, food, gas, etc. And be able to spend time with our children and families.”

“The prices of everything have gone up drastically but wages remain the same.”

“Higher wages because I could support my family better.”

CAPWI's Current Strategies:

- Assist people with job goals and support
- Connect people with job training and workforce programs

Possible Future Strategies:

- Partner with local employers and organizations to create more job opportunities or determine what is available
- Create additional internship opportunities with local high schools and vocational programs

Affordable, Accessible Childcare

High-quality childcare that remains affordable for households is critical to the advancement of both children and workers, with this twofold investment enabling parents to contribute to the economy while their children have access to enriching care. Unfortunately, for many Hoosiers, the price tag of childcare puts it out of reach, with the average annual cost of care for infants and toddlers coming to \$15,776 (a monthly \$1,314.67).^{xxxvi} This hefty price tag means that a household earning the state's median income of \$72,386 annually would spend 21% of its pre-tax income on childcare.^{xxxvii} While this is a high cost, it is also important to recognize the reasons behind that cost: childcare centers face strict staff-to-child ratios, high operational expenses, and a landscape of limited public funding options to offset these inputs when providing safe, quality childcare to households.^{xxxviii} Limited profit margins in childcare facilities also result in the underpayment of childcare workers, who earn a median annual salary of \$32,050.^{xxxix}

“If I got a job all my income will go straight to childcare and I won’t have anything for bills etc.”

While 2023 efforts to improve access to childcare in the wake of expiring COVID-19 funds succeeded, with Indiana expanding eligibility for programs such as the Childcare Development Fund (CCDF) and On My Way Pre-K (OMWPK) to 150% of the Federal Poverty Level,^{xi} such changes were not matched by sufficient investment in program expansion. This has led to a backlog in enrollment and, as of December 2024, to the reinstatement of waiting lists for access. Indeed, even as the expansions enacted in 2023 have increased access to childcare in terms of overall number of recipients, state advocates highlight key concerns that remain, particularly the long wait times that households experience to gain access to these services.

IN HOOSIERS' OWN WORDS

“Hard to find any that won't break budget so I can work and know my kids are safe.”

“Many families have had to quit their jobs because they cannot afford childcare with the current vouchers.

The income based ones are full. There is also a lack of resources for those who barely make over the limit who are struggling to pay bills because of the cost of childcare.”

“My husband pays \$1,000 a month in support and we also have 2 kids...Him being a trucker, I simply cannot make enough to supply daycare \$1,000 a month on top of what he is paying out...It would be part time work in which would not be worth the \$1,000 a month in daycare costs.”

The concern with waitlists and delayed enrollment is significant: childcare brings demonstrable benefits to children, families, and employers within the community. When childcare is unattainable for families, it is often women who are expected to step back from the labor force, leaving their roles in the economy vacant.^{xli} In single-parent households, not working is usually not an option, leaving that family in a state of uncertainty as they struggle to access safe, quality childcare while ensuring overall financial stability for their household.^{xlii} Lack of access to childcare has also been associated with decreased female health outcomes, as women perform more unpaid care duties within the household and, as a result, struggle to find time for their own care or doctor's appointments.^{xliii} Just as seriously, prioritizing childcare and its access across socioeconomic groupings has been associated with increased childhood health, achievement, and educational attainments, highlighting the ways in which childcare as a community good ultimately is manifested within broader social circles.^{xliv} These cumulative benefits from childcare and the resulting harms from its inaccessibility underscore the need to ensure childcare access remains attainable within Indiana.

CAPWI's Current Strategies:

- Provide early childhood education and family supports
- Provide childcare programming in some counties
- Assist families in finding childcare resources

Possible Future Strategies:

- Expand current childcare programming

Food Assistance

A common experience for impoverished households is food insecurity, which occurs when there is not enough consistent food for all members of a household.^{xlv} Households are deemed to have very low food security when those in the home disrupt their food intake due to lack of income, such as skipping meals.^{xlvi} In the U.S., food insecurity impacts over 10% of Americans.^{xlvii} In the state of Indiana between 2021-2023, the average prevalence of food insecurity was 12.1%, and 5.3% of Hoosiers experienced very low food security, which has increased from the 2018-2020 period (11.6% food insecure and 4.4% having very low food security).^{xlviii} Financial instability brought on partly by the COVID-19 pandemic contributed to this increase in food-insecure households and worsened conditions for families in poverty.^{xlix} Geography also affects access to food, with rural communities facing higher food prices due to the lack of grocery stores and the localized monopolies that can exist in less urban areas, driving up costs for basic services.ⁱ

“Assistance with food! With 2 adults working both full-time jobs still can't afford meals per week & denied assistance when there are children going hungry. Some people who have food allergies are unable to afford their safe foods due to high prices as well.”

IN HOOSIERS' OWN WORDS

“Groceries have gone up significantly and our pay has not.”

“After paying bills to be able to have a roof over our heads. It's hard to keep food in our mouths.”

“Food assistance because so many people struggle to just simply make ends meet let alone put food on the table.”

“Assistance with food affordability because it is a struggle to get \$200 worth of groceries every 2 weeks on top of all of our bills. We do not qualify for SNAP, so we budget with dinner plans and grocery lists every two weeks to try and afford food.”

Access to affordable, healthy foods is imperative for the health and well-being of CAPWI communities and is tied to health outcomes. For example, public health interventions increasing food access to vegetables and fruits for food-insecure low-income patients with hypertension have been shown to reduce negative health outcomes.^{li} Therefore, efforts to improve food access can help prevent worsening health conditions and ensure the health and well-being of Hoosier communities.

“Food and assistance because of how expensive housing is, we are hardly able to afford the groceries with the prices also high at local stores.”

CAPWI’s Current Strategies:

- Partner with food banks, schools, and community groups to assist with food needs
- Assist households in applying for SNAP and connect them to food resources
- Provide weekly “buddy bags” of food for Head Start families

Possible Future Strategies:

- Partner with community gardens
- Increase healthy food and nutrition education

Utility Affordability and Assistance

Access to electricity, natural gas, and water in housing are essential for Hoosiers across the state, as each of these can influence both physical and mental health, financial opportunity, and stable environments for children. But as these essential utility costs keep rising, many Hoosiers have been forced to choose between paying their electricity bill or paying for other essentials like healthcare, childcare, or car payments. In just the past year, the average electricity cost paid by Hoosiers has surged by a record-breaking 17.5%.^{lii} This is compounded by increases in water and gas prices and impacts Hoosiers statewide,^{liii} with rate increases most severely impacting lowest-income households.^{liv} In addition to utility bills costing those families a larger share of their total income, low-income households are also more likely to live in homes that are not energy efficient.^{lv} Houses that have insufficient insulation, water leaks or damp, mold growth, or other issues can further increase the cost of utilities for residents in those homes.^{lvi} There are programs that offer support when families cannot afford to pay a utility bill, such as the Low-Income Home Energy Assistance Program (LIHEAP).^{lvii} This program supports households with weatherization services to address poor insulation, payment assistance for heating in winter months, or emergency assistance when a crisis hits. To be eligible for this program, households must earn below 60% of the state median income.^{lviii} This eligibility criteria creates a benefit cliff that leaves out many households who are still struggling to afford their utility costs, but whose household incomes fall just above the threshold for assistance.^{lix} More concerning, however, is that even for families below that income threshold, only one in five actually receives assistance from the program.^{lx} This means that while 122,229 households struggling with utilities in Indiana receive assistance from LIHEAP, more than 611,000 additional Hoosier households are eligible for assistance but do not receive it because of insufficient program funding.

IN HOOSIERS' OWN WORDS

“I see so many people struggling with their electric bills specifically, especially during winter. **Mine alone jumped almost \$250. When you are on a budget, that kind of jump can really break you.**”

“**Electric (utilities) because it is required by every household and we have no alternative companies. It is a monopoly for our area.**”

“**Utility affordability, because it is a necessary cost that's too high.** Medicine costs are also too high. Some of us are forced to choose.”

“**Our propane literally doubled from last year, and electric keeps creeping higher.**”

The consequences of not being able to afford utilities are severe. Electricity, water, and natural gas can each be shut off by utility providers in the event of non-payment.^{lxi} These shutoffs create additional sources of stress and disruption for households that are already struggling, as essentials such as cooking, bathing, and heating become inaccessible.^{lxii} Children, individuals with disabilities, pregnant women, and elderly individuals face additional challenges from these disconnections, as they can interrupt access to lifesaving medication that requires refrigeration, access to medical equipment reliant on electricity, and the maintenance of a home at a safe temperature during extreme heat waves or cold spells.^{lxiii} Interruptions to utilities also create challenges for working individuals, who may then struggle to access wi-fi or maintain grooming standards expected in their workplace. Such challenges can also impact children attending school.^{lxiv} Even after a household has access to utilities restored - a task often made more difficult by expensive reconnection fees - the physical and mental health effects of not having reliable utility access can linger.^{lxv} Utility access and affordability are essential components of domestic well-being that, when compromised, can lead to rippling impacts outside of the home, making it an essential need to address within communities.

CAPWI's Current Strategies:

- Connect Hoosiers in need with Housing Choice Vouchers
- Connect individuals with Individual Development Accounts so they can save to purchase a home
- Provide weatherization and other housing quality improvement services
- Provide energy assistance programs to help households keep utilities
- Help clients avoid shutoffs and restore services
- Offering budgeting and energy-saving tips
- Connect households with emergency assistance resources
- Assist vulnerable households during extreme weather

Possible Future Strategies:

- Offer eviction diversion support
- Participate in the Continuum of Care to address homelessness
- Continue to invest in or collaborate to create affordable housing options
- Provide weatherization education to the general public
- Create emergency plans for households impacted by extreme weather or utility issues

Civic Engagement

Since their founding, Community Action Agencies have invested in the participation of low-income individuals in civic life.

The first programs...understood that restoring inclusivity required programs to instill a sense of political empowerment in their customers. Actual, meaningful access to the polls gives people experiencing low incomes the chance to help shape their own futures. In the words of Robert Kennedy, Sr., “maximum feasible participation means giving the poor a real voice in their institutions.” -Community Action Partnership

CAPWI is already actively working to address the top needs through its programs and referrals to its robust network of community partners. Continuing to address the top community needs will require resources and interventions at the family, agency, and community levels.

- Resources to better meet basic needs such as nutrition, housing, and transportation
- Connection to existing resources and training opportunities to obtain good jobs
- Wrap-around supports and education
- Knowledge of legal rights and responsibilities
- Expand youth programming opportunities

Agency

- Funding to expand services
- Partnerships to meet top community needs
- Professional development and networking opportunities to build staff capacity
- Strengthen interagency referrals for clients

Community

- Energy support and efficiency programs
- Greater supply of affordable housing and housing supports
- Employers offering family-sustaining wages/benefits and education/skills pathways to good jobs
- Programs and services to provide greater access to nutrition, transportation, and employment services
- Events and partnerships to educate policymakers and advocate for community-wide change

Ensuring financial well-being and contributing to thriving communities is work that evolves over time. Community Action Agencies have consistently been leaders in that respect, with attention to the needs of community members and programs that have adapted and evolved over time to meet these needs. Through interconnected and holistic approaches to fostering well-being, the Community Action Agencies can help foster cohesion among regional partners and ensure that the complex work of addressing the causes and conditions of poverty in Indiana continues to be carried forward to empower future generations.
